In collaboration with Gashbun coordinator, PSEA project senior officer, the community mobilizers will be responsible for the following:

- Organize awareness group sessions on PSEA
- Conduct meetings with community-based committees.
- o Provide weekly reports to project senior officer.
- Organize capacity building training sessions with service providers and concerned government departments
- Ensures that Survivor Centered Approach Guiding principles maintained and enforced in, while working with survivors, including in safe space for survivors during the sessions/meetings and activities in the GASHBUN Centers.

### **Case Worker's duties**

- Provide direct support and care for vulnerable women and girls, including basic information counseling and assessment of survivor needs, developing an action plan, implementing the plan, follow up and case closure processes in line with the GASHBUN S/GBV Standard Operating Procedure (SOP)
- o Participate in "Service Providers Mapping" activities in the area of GASHBUN interventions
- Support individuals in risk of PSEA, by referring them to group or individual sessions when necessary and in respect of their consent to other service providers.
- o Prepare and provide consent forms to participants if necessary
- Ensure Do No Harm approach is applied in all activities conducted in work with SEAH survivors and other GASHBUN's beneficiaries
- o Identify opportunities for awareness rising, whether in a GASHBUN facilities, community centers or other safe spaces; plan the sessions; conduct the sessions
- Prepare, organize and conduct focus group discussions (FGD) on relevant topics/information collection, when needed
- Identify protection concerns of women, girls, men and boys within the community in the area of
  intervention; i.e., any trends should be reported to the concerned Gashbun department that will be
  specified after being employed and advocate for gaps in SEAH response and referral procedures
- Receive referrals, take action and provide feedback of actions taken in a timely manner to the project senior officer, coordinator and other agencies when necessary.
